

Minutes of the Organizational Meeting of the Village of Alix Council, held on Wednesday, October 3, 2018 in the Village of Alix Council Chambers at 6:00 P.M.

Call to Order: Mayor Fehr called the meeting to order at 6:00 P.M. and turned the Chair over to the Chief Administrative Officer Michelle White.
