

VILLAGE OF ALIX

BYLAW No. 447/19

BEING a Bylaw to authorize the rates of taxation to be levied against assessable property within the Village of Alix in the province of Alberta for the 2019 taxation year.

WHEREAS the Village of Alix has prepared and adopted detailed estimates of the municipal revenues and expenditures as required, at the council meeting held on December 5, 2018 and amended on May 15, 2019; and

WHEREAS the estimated municipal operating expenditures and transfers set out in the budget the Village of Alix for 2019 total \$2,739,494.26; and

WHEREAS the estimated amount required to fund reserves is \$15,000.00 and the estimated amount required for future financial plans is \$15,407.80; and

WHEREAS the estimated municipal operating revenues from transfers from all sources other than taxation is estimated at \$1,090,532.00, and the balance of \$1,679,370.06, is to be raised by general municipal taxation; and

WHEREAS the requisitions are:

WHEREAS the Council of the Village of Alix is required each year to levy on the assessed value of all property, tax rates sufficient to meet the estimated expenditures and the requisitions; and

WHEREAS the Council is authorized to classify assessed property, and to establish different rates of taxation in respect to each class of property, subject to the Municipal Government Act, Chapter M-26, Revised Statutes of Alberta, 2000; and

WHEREAS the assessed value of all property in the Village of Alix as shown on the assessment roll is:

NOW THEREFORE under the authority of the Municipal Government Act, the Council of the Village of Alix, in the Province of Alberta, enacts as follows:

1. That the Chief Administrative Officer is hereby authorized to levy the following rates of taxation on the assessed value of all property as shown on the assessment roll of the Village of Alix:
