FURTHER INFORMATION MAY ALSO BE REQUIRED

Note:

1. First time applicants who already have an accessory building (garage, garden shed etc.) on the property stated above will be required to successfully obtain a Development Permit before a Chicken License can be granted.

2. The Chief Administrative Officer may refuse to accept an application for an Urban Chicken License where the required information is not supplied or where, in his/her opinion, the quality of the material supplied is inadequate to properly evaluate the application.
3. The Chief Administrative Officer may deal with an application without all of the information required if he/she is of the opinion that a decision of the application can be properly made without such information.
4. If an Urban Chicken License is issued for this application, it is effective from January 1 to December 31 of the application year only.
5. The granting of this license shall in no way relieve the property owner from complying with the requirements of the Village of Alix Urban Chicken Bylaw 430/18, or any other bylaws of the Village of Alix, or other Provincial or Federal Statutes or Regulations in force.
